### 4. Staff Update - Briefing by King County and City of Seattle staff

Jenny Durkan welcomed Helen Howell to her new role as Interim Director of the Seattle Human Services Department.

### Staff Update: Leo Flor, Director of King County Department of Community and Human Services:

- Transition timeline remains on schedule.
- Confirmed that 18 of 19 members of the Advisory Committee have been seated.
- Implementation Board is preparing to work with future CEO on Work Plan.
- CEO onboarding preparations are under way.
- The King County Continuum of Care decided to seek a waiver offered by HUD to skip the inperson Point in Time count due to COVID risks, consistent with other waivers sought by neighboring regions. Survey-based and HMIA-based counts will still proceed.

### GC Comments:

- Nancy Backus: expressed concern over the three different methodologies for the homelessness counts in the past five years and the subsequent inconsistencies, understanding the reasons for this year's change.
- Zaneta Reid: understands the concern for COVID risk, but asked if appropriate precautions could have been taken to proceed with an in-person count.
- Jenny Durkan: noted CoC Board is a separate entity that made this decision, and the importance of GC members to have opportunity to share concerns.
- Johnathan Hemphill: expressed concern that no in-person Point in Time count will be missed opportunity to capture full magnitude of count.

 Presented timeline update, including scheduled interviews and expected confirmation schedule.
